**Sales Discount 2007**

A Sales Discount will be credited to the current consumer at each metered supply point (ICP) at the discount date of 31 January 2007. The discount will be \$50 plus 22.5% of the total fixed and variable Network (Line and Transmission) charges paid by that consumer at that ICP for the previous twelve months.

**Power Factor Charge**

This applies to commercial customers. Where the power factor is less than 0.95 Electra reserves the right to impose a power factor charge. The charge will be based on a multiplier of 2% of the monthly total Line charges for every 0.01 power factor below 0.95 lagging.

The new variable Line Function prices include a Consumer Price Index increase passed on to you within Commerce Commission rules for electricity lines companies.

Transmission prices are passed directly through to you based on what Transpower charges Electra. We have been advised that these are due to increase on 1 April and the new transmission prices reflect this.
